- ✦ Search the extensive vendor database and generate comprehensive reports.



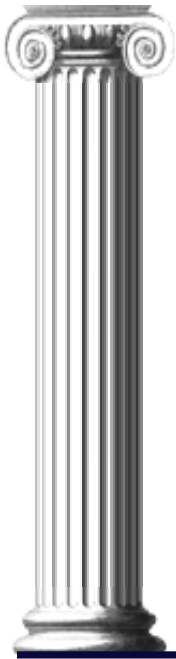
### Outreach management

- ✦ Alert contacts of upcoming insurance expiration



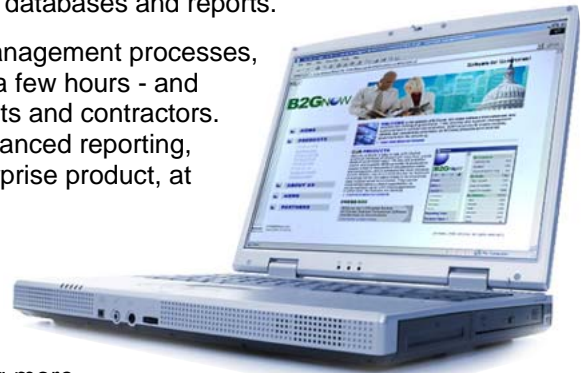
